

## Participating School Districts for LBCC Education Course Fieldwork

The LBCC Reading and Teacher Preparation Department and Tomorrow's Teachers Teacher Preparation Program have chosen high quality school districts and schools that meet the fieldwork requirement of your Education course. This includes placement at a public school in the general education classroom of one credentialed teacher who has at least 3 years of experience. Classrooms may <u>not</u> be special education classrooms, computer labs, after school programs, etc. and observation/volunteering must be conducted during regular school hours\*.

- **Education 10** students will be placed in one of the approved districts on this list in a TK-8 classroom to complete 10 hours of fieldwork.
- **Education 20** students will either be placed in a TK-6 elementary classroom in LBUSD or another district to complete 45 hours of fieldwork.
- **EDUC 130** students will be placed in a grade 8-12 secondary classroom for 10 hours of fieldwork. An additional 5 hours of fieldwork can extend outside of the classroom.

\*Pandemic Response Note: Fieldwork requirements for the course are subject to change pending policy updates from the CSU, CTC and pending district reopening plans. Fieldwork may include a combination of alternative placements, virtual classroom observation &/or in-person at a school site.

Students are required to attend a **Program Orientation** to review the fieldwork requirement and to receive the correct registration process instructions. The process will include the correct Livescan fingerprinting forms and instructions for your placement type. Look for information to be shared via email, on the LBCC calendar of events/In The Loop, and posted to Canvas prior to the start of your semester.
